- 3. Judicial Affidavit declaring "Neither the firms nor its Directors, Stakeholders, as a whole or as a part of the firm have ever been blacklisted / defaulted by any government agency/department/organization".
- 4. Provide separate undertaking that the information supplied by the firm is correct.
- 5. Certificate of registration with (PEC) having along with the latest renewal letter and having relevant project profile code 1201 and service codes 0542, 0543, 0546, 0547.
- 6. Copy of Registration with Securities & Exchange Commission or Registrar of Firms.
- 7. Valid Registration with Punjab Revenue Authority.
- 8. CVs of qualified professionals as mentioned in the Pre-qualification Documents & Experience.
- 9. Audited Financial Statements for the last three (3) years.
- 10. Copy of registration with Income Tax Department / Sales Tax department with active taxpayer status, which can be verifiable on FBR portal.
- 11. The firms should have valid certifications for ISO 9001:2015 for Quality Management System, ISO 14001:2015 for Occupational health and safety (OH&S) Management System.
